#### **HUMAN TRAFFICKING AND THE IMPACT ON COMMERCIAL DRIVER'S LICENSES**

Commercial Driver License (CDL) holders have the privilege of operating 80,000-pound vehicles, and with that privilege comes greater training, licensing expectations, and responsibility. This presentation will analyze the rules and regulations regarding CMV operators/CDL holders and severe forms of human trafficking. This session will educate attendees about the Federal "No Human Trafficking on Our Roads" (NHTRA) which was signed into law on January 1, 2018. The mandatory lifetime disqualification without the possibility of reinstatement applies to those who engage in the use of a commercial vehicle for sex or labor trafficking.
