Background

The Louisiana Primary Care Accountable Care Organization, LLC (LPCACO) is a network of twenty-eight Federally Qualified Health Centers (FQHC) founded in order to enter the Medicare Shared Savings Program (MSSP) for the 2017 program year and to combine collective resources and leverage the deep knowledge base of leading primary care provider organizations throughout Louisiana for the purpose of improving health outcomes and reducing healthcare costs for the more than 461,000 patients served annually.

This RFP is designed to assist LPCACO leadership in identifying a compliance consultant to provide Board training and corporate compliance consulting to ensure that the Board understands its inherent legal duties of care, loyalty, and obedience; and to assist the Board in maintaining an effective compliance program in conformity with federal regulations.

- Demonstrated experience with Federally Qualified Health Centers, Accountable Care Organizations, and/or Clinically Integrated Networks.
