

Dr. Gary Wiltz, CEO of Teche Action Clinic, is elected as **Board President** of the National Association of Community Health Centers.

2014

At this time, there are 30 FQHC grantees in the state of Louisiana. These Health Centers now see over 300,000 patients a year.

The Louisiana Community **Health Center Caucus** is established in the Louisiana Legislature. At the time of establishment, 87 members of the Legislature were part of the caucus.



LPCA moves to its new office at 503 **Colonial Drive**

LPCA contracts with an Independent Practice Association (IPA) that works with FQHCs and contracted health plans to improve the quality of care at FQHCs.

Health Centers across the country celebrate the **50 year anniversary** of the Health Center Program.

Gov. John Bel Edwards expands the **Medicaid program**, making care more accessible to thousands of patients.

2017

Louisiana's **34 FQHC organizations** collectively operate over 240 healthcare facilities, serving nearly 385,000 patients.

The Louisiana Primary Care Accountable **Care Organization** is founded in order to enter the Medicare Shared Savings Program.

With 16 staff members. LPCA continues to grow, expanding services and increasing assistance provided to Louisiana's FQHCs.

The city of New Orleans is ravaged by **Hurricane** Katrina. Community Health Centers rise to the challenge and work to serve displaced patients.

The **Greater New Orleans Community Health** Connection (GNOCHC), a Medicaid demonstration waiver, is created in an effort to expand primary care and behavioral health services in the Greater New Orleans region.

LPCA begins statewide capital development program known as the Facility Expansion **Initiative** in 2006.

The FEI was based upon a statewide strategic plan that identified a specific list of Community Health Center capital needs.

In 2007, legislation signed by Gov. Kathleen Blanco awarded Health Centers with \$41.5 million to be used for capital projects.

President Barack Obama signs the Affordable Care **Act**, one of his signature legislative achievements. This law provides FQHCs with \$11 billion over 5 years.

The **BP Deepwater Horizon** spills 4.9 million barrels of oil off the coast of Louisiana. making access to primary care essential for residents on the Gulf Coast.

2010

Under Gov. Bobby Jindal, Louisiana transitions its Medicaid program to "Bayou Health" - now "Healthy Louisiana."

LPCA introduces the inaugural **Eric B. Taylor Leadership Award**, in honor of the former CEO of SWLA Center for Health Services.

LPCA is awarded the Health Center Controlled Network (HCCN) grant.
