**Behavioral Health Consultant – Spanish Speaking for Pediatrics & Adolescents for Immigrant and Refugee Focus**

The Behavioral Health Consultant (BHC) will provide brief, evidence-based services in a consultative model to clients/patients and their primary care providers.

The BHC will work as a part of team-based care and provide mostly same day services.

Service focus on:

- 1) Consultation to pediatrics and adolescent team and psychiatrists
- 2) Recommendations regarding behavioral health treatment
- 3) Brief intervention with clients referred by the primary care or Client Services team

The goal of BHC services is to increase client wellness and satisfaction by improving access to behavioral health services within the primary care setting.

Position will specifically focus on the care of children and adolescents who are a part of CrescentCare's Pediatric/Adolescent Refugee & Immigrant Health program (partnership with Tulane and Children's Health Fund).

**Required**

- Must be Bilingual, fluent in written and spoken Spanish and English

- Knowledge of, and the desire to work with, a cross-disability population including immigrant & refugee populations with exposure to trauma
- Ability to communicate effectively with diverse individuals and groups, such as those seen by an immigrant and refugee-focused pediatric and adolescent program
- Proven experience in the ability to handle crisis intervention
- HIV/AIDS knowledge and patient experience
- Experience with the LGBT community
- Must have reliable transportation, and proof of car insurance (if applicable) to travel throughout the community as required
- Obtains CPI certification within 3 months of employment (employer will arrange)
- Will work limited evening and weekend hours as needed
- Demonstrated Technical & Computer Skills Required for the Position
- Minimum age of 21

- **Master's Degree** from a CACREP Accredited Institution or Equivalent Counseling Degree from Accredited Institution.
