Louisiana Federally Qualified Health Center Accountable Care Network Delivers Just Under \$6M in Savings for Medicare Beneficiaries

New Medicare data shows Louisiana Federally Qualified Health Centers (FQHC) 2019 clinical performance improves the lives of 10,000 elderly in Louisiana

Baton Rouge, LA – The Louisiana Primary Care Accountable Care Organization, LLC (LPCACO) is pleased to report a savings in cost of care of just under \$6M for 11,000 Medicare beneficiaries. **The 2019 savings represents a 96% increase in total savings over 2018 and \$578 savings per beneficiary.**

LPCACO participating health centers improved the delivery of preventive care by increasing primary care services by 8%; decreasing hospital readmissions by 19%; decreasing unnecessary emergency room visits by 13%; and decreasing inpatient hospitalization by 8%.

LPCACO is a network of twenty eight Federally Qualified Health Centers (FQHC) formed in 2017 to combine collective resources and leverage the deep knowledge base of leading primary care provider organizations throughout Louisiana for the purpose of improving health outcomes and reducing healthcare costs for the more than 461,000 patients served annually.
