DBE PROGRAM BASICS

- The Goals of 49 CFR Part 26
 - To ensure nondiscrimination in the award and administration of DOT assisted contracts for highway, transit, and airport programs
 - To create a level playing field on which DBE's can compete fairly for DOT assisted contracts
 - To eliminate barriers to the participation of DBE firms in DOT assisted contracts
- The DBE Program is federally mandated for airports, transit agencies, and transportation agencies who receive grants from the Department of Transportation (DOT) in excess of \$250,000.

DBE CERTIFICATION ELIGIBILITY

- Socially AND Economically **Disadvantaged**
 - Small Business **Size Standards**
 - SBA Annual **Gross Receipts** Standards
 - **Personal Net Worth:** NTE \$1.32 million
 - **Ownership:** 51% minority or women
 - **Control:** day-to-day management and direction
- Presumed Disadvantaged
 - Women
 - African Americans
 - Hispanic Americans
 - Native Americans
 - Asian-Pacific Americans
 - Subcontinent Asian Americans
 - OR Case-by-Case determination

DBE CERTIFYING AGENCIES

BENEFITS OF BECOMING DBE CERTIFIED

- Certification is recognized by all airport, highway, transportation, and transit agencies in the state.
- Certified firms are open to opportunities to participate in federally-funded contracts
- Your firm will be listed in the LAUCP directory of certified DBE firms and will be accessible to all prime contractors needing to fulfill DBE participation goal requirements
- Certification increases opportunities to network with prime firms and public agencies at procurement fairs and pre-bid conferences
- Certification opens up opportunities for bonding assistance, small business loans, mentor-protégé programs, and other small business support services

I'M DBE CERTIFIED, NOW WHAT?

- Be Proactive!
- Watch for new solicitations and opportunities at BRMA and beyond
- Meet with prime firms prior to and during solicitation
- Market your firm
- Network
- Be prepared
- Attend pre-bid conferences
- Be sure your NAICS description is current and complete

DBE GOALS

- Overall Goal
 - Calculated based on a set methodology to determine the overall goal for the next three years
- Contract Goals
 - Calculated for each federally funded procurement prior to solicitation
 - Goals are calculated based on the type of work required for the contract and the number of ready, willing, and able DBE firms and total firms available to participate in the project

PROPOSED OVERALL DBE GOAL 2021-2023

- The proposed Overall DBE Goal was calculated based on the availability of ready, willing, and able DBE firms to perform the work necessary to accomplish the six projects anticipated for federal fiscal years 2021-2023.
- The public comment period is now open through October 31st and your feedback is welcome.

REQUIREMENTS

DBE PROGRAM REQUIREMENTS

- Prime firms bidding on federally funded projects **MUST** demonstrate compliance with the DBE Program at the time of bidding by either:
 - Meeting the DBE Contract Goal established for the project; OR
 - Making Good Faith Efforts to meet the goal and providing supporting documentation of such efforts

BID REQUIREMENTS

- Schedule A – Prime firm commits to DBE participation and states all subcontractors participating in the project including scope and value of work for each firm.
- Schedule B – Each participating firm completes the survey and confirms scope and value of work to be performed.
- Schedule C – Demonstrates Good Faith Efforts to include DBE participation.

CONTRACT PARTICIPATION AND DBE COMMITMENT (SCHEDULE A)

- Lists all participating firms and the scope and value of work for each firm (including Prime and all tier subconsultants)
- Must equal total bid amount including any alternates
- Demonstrates commitment to DBE firms and total DBE participation in dollars (bid) and/or % (qualifications or proposals)
- Completed and submitted by the two apparent low bidders within 3 days of bid opening

REQUIRED PARTICIPATION QUESTIONNAIRE (SCHEDULE B)

- Contractor information reported on this form is required by the FAA
- Form confirms scope and value of work to be performed by subcontractors
- The two apparent low bidders must submit a Schedule B for EACH participating firm (including the Prime) within 3 days of the bid opening

GOOD FAITH EFFORTS (GFE) TO SECURE DBE PARTICIPATION (SCHEDULE C)

- Documents efforts taken to meet DBE contract goal
- Guides bidders through GFE process
- Completed and submitted by two apparent low bidders
- Documentation of GFE required for bidders who failed to meet the DBE contract goal but recommended of all bidders
