They will play a key role in the identification and creation of data collection instruments as well as data management and analysis, and will support the Director of Evaluation in synthesizing and presenting evaluation results to internal and external audiences. DSCEJ is committed to participatory and utilization-focused evaluation, and the ideal candidate would be creative in their evaluative thinking and methodological approach.

Duties & Responsibilities

- Coordinate program evaluation activities across DSCEJ programs and divisions;
- Contribute to evaluation planning with program teams, external partners and community members:
- Conduct formative research and create data collection instruments;
- Coordinate data collection, management, and analysis for programmatic evaluations;
- Contribute to funding proposals;
- Contribute to planning, writing, and creating manuscripts, reports and presentations;
- Translate findings and create data visualization tools;
- Work closely with program teams to track quality of programs and ensure that deliverables are being met;
- Coordinate scheduling of project meetings as needed.

- Experience or training in quantitative and qualitative methods
- Familiarity with database management software and data analysis software

- Application of an equity and justice lens to research & evaluation
- Strong data management, organizational, and communication skills
- Successful applicants may have a Master's degree in public health, social work, sociology, or similar fields; however, professional and lived experiences are valued in complement to, or in replacement of, academic experience.
