DIRECTIONS TO THE TRIAL SITE

From 1-10 take EXIT 177. Go west on Highway 30 (Tanger Outlet Mall). Turn left on St. Landry Road. The entrance to Lamar-Dixon Expo Center will be about 1 mile on the right. The Trademart Building is near the south side of this complex. Follow the blue arrow signs.

MATCH/PRACTICE RING INFORMATION

Ring time available in 5 or 10 minute slots. Practice ring is \$20 per handler for the entire weekend.

Four rings will be available with a timer at each ring
Ring stewards and pattern callers may not be available.

Match Start Time

Starting as soon as ring set-up is complete (approximately 2:00 p.m.) ending at 8:00 p.m.
A time and running order will be sent back to you by e-mail by Tuesday, the week of the trial.

Match Pre-Entries Closing Date:

Costs:

5 min. slots: \$7 per dog, per entry;
10 min. slots: \$12 per dog, per entry
(Ways are included in entry fee)

Dogs must be at least 6 months old on the day of the Match.

Food and/or toys will be allowed.

No food can be put on center post for go outs or thrown on ring floor

No harsh, intensive, or abusive training will be allowed.

All pre-entries will show first -- otherwise you will go to the end of the complete running list . Any pre-entry sold from the original exhibitor will go to the end of the running order.

REMINDERS and EXHIBITOR INFORMATION

Entries:

Entry forms must be signed. Double check all information prior to signing the entry form. If entering Rally Advanced and Rally Excellent, include your jump height in the appropriate box on the entry form. Catalog order in these classes will be based on jump height. This premium list may be downloaded from our website, please be sure to attach the "Agreement" page, *which is necessary for a valid entry*.

Move-Ups are allowed in accordance with AKC regulations. Move-Ups will be accepted until 30 minutes prior to the start of judging for the first class each trial.

Checks that have been returned due to insufficient funds do not constitute a valid entry. Entry fees will not be refunded if a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed because of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees for bitches coming in season after entries close will be refunded with written certification from a veterinarian presented to the Trial Secretary at least 30 minutes prior to the start of judging the first class.

No conditional entry shall be accepted. Entries will not be accepted without fees (check or money order if sent by mail or PayPal if submitted electronically) or signatures. Changes, additions, or corrections to entry forms must be received in writing or by email *prior to the close of entries*.

Trial Grounds:

The building will be open for Exhibitors beginning at 7am Saturday and Sunday, May 29 and 30, and must be vacated immediately following the awarding of High in Trial each day.

DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES. If any dog seems to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Trial Committee and/or the AKC for disciplinary action. All persons attending this show hereby waive any claim against the Louisiana Capital City Obedience Club and its members, in the event a motor vehicle is entered to rescue a dog from overheating or suffocation due to improper ventilation.

All dogs must be on leash when not in the ring. Dogs are not allowed in restrooms.

There will be crating space available, but please do not bring dogs not entered in the trial. Please crate in the labeled spaces, between the blue tape only and be sure not to block someone else's crate access.

Dogs must be ready for judging. Neither LCCOC nor any ring steward will be responsible for calling or notifying exhibitors that they are due in the ring. Please check the boards ringside.

Exhibitors must clean up after their dogs at the Trial site and at the motels. There will be a designated exercise area at the Trial site.

Neither the Louisiana Capital City Obedience Club nor any Trial official will assume responsibility for any loss, theft, damage or it sustained by exhibitors or any of their dogs, children, or property.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Hospitality will be available at the Trial site. There are fast food and full-service restaurants near the trial site.

COVID regulations may apply. Please be mindful of your space around others and wash your hands frequently. Mask mandate will depend on local regulations at time of trial.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
