Life	Fetal Heartbeat Detection	SB 1961/HB 1892	Prohibits abortions from the point a fetal heartbeat is detected; requires fetal heartbeat testing prior to an abortion; creates exceptions.	No action taken in the House or Senate.
Life	Distribution of Medicare/Medicaid Funding	SB 2148/HB 2251	The bill would direct the commissioner of F&A to submit a request for a waiver to the centers for Medicare and Medicaid to exclude such entities if the Bureau of TennCare determines that the inclusion of the provider would result in the direct or indirect use of state funds to promote or support elective abortion. Religious Liberty	Political involvement of churches	SB 403/HB 609	Exempts churches and religious organizations from the requirements applicable to Political Action Committees (PACs) when spending funds in favor or opposition to ballot measures related to morality, such as alcohol, drugs, abortion, marriage, or gambling.
