#### PROPOSED BY-LAWS AMENDMENTS

(To be submitted at the Clerks Only meeting at Annual Convention on April 19, 2011)

## 1. Amend Article VII, Section 2

#### Section 2. Duties

- Each District Representative is encouraged to hold quarterly district

  meetings to provide opportunity for Clerks in said district to exchange

  ideas on the operation of their offices; cultivate friendships among the

  district members; and to participate in the formulation and advancement

  of official policies of the Association
- (b) If such meetings are conducted and recommendations, actions, or ideas are set forth by the respective districts, a written report shall be presented by the District Representative to the Board.
- (c) If a District Representative is unable to attend a quarterly Board meeting.

  he/she shall submit his/her written report to the President of the

  Association prior to the Board meeting.
- (d) (a) If the Board of Directors should determine that the appointment of an Executive Director is desirable, then the Board of Directors shall appoint an Executive Director of the Association. The Board of Directors shall set the salary for the Executive Director at the time of appointment.
- (e) (b) Approve an annual budget prior to the beginning of the new fiscal year.
- (f) (e) Approve the engagement letter to hire the auditor to perform the annual audit.
- (g) (d) Approve programs for the annual conference.
