- Ends: **Friday, July 24, 2020** at 4:30PM

REGISTER TO VOTE

- The last day to register to Vote for the November 3, 2020 election is **Monday, October 5, 2020**
- **Register In Person** at the Iberia Parish Registrar of Voters Office, Iberia Parish Courthouse, first floor
- **Register On Line** at www.geauxvote.com

EARLY VOTING

- Begins: **Tuesday, October 22, 2020** from 8:30AM – 6:30PM
- Ends: **Tuesday, October 27, 2020** from 8:30AM – 6:30PM
- Early vote at the Iberia Parish Registrar of Voters Office, Iberia Parish Courthouse, first floor

FILE FOR WATCHERS

- The last day to file for watchers is **Monday, October 25, 2020** at 4:30PM

- **Friday, October 30, 2020**

ELECTION DAY

- **Tuesday, November 3, 2020** from 6:00AM – 8:00PM
