COMPREHENSIVE HIGH—IMPACT HIV PROGRAM GOALS





DIAGNOSE

Goal: Prevent New Infections

- Louisiana Objective 1A: By 2021 increase the percentage of people living with HIV in Louisiana who know their serostatus to at least 90%.
- Louisiana Strategy 1A-1: Support Targeted HIV Counseling and Testing in community-based settings that maintain at least 1.0% new diagnosis rates

1-year Program Objectives: By June 30, 2022:

- At least 600 individuals from the targeted population, HRH African Americans residing in the NO EMA, become aware of their serostatus by receiving targeted HIV testing
- At least 450 (75%) of persons tested are part of the selected target population.
- At least 1 Large HIV Testing Event is implemented.
- At least 10 (1.67%) newly diagnosed HIV- positive individuals are identified.
- At least 75% of PS21-2102 HIV testing events conducted in which the client was provided screening for STDs (syphilis, gonorrhea, chlamydia), viral hepatitis, or TB in conjunction with PS21-2102 funded HIV testing

5-year Program Objectives: By June 30, 2026:

- At least 3,000 individuals from the targeted population, HRH African Americans residing in the NO EMA, become aware of their serostatus by receiving targeted HIV testing
- At least 2,250 (75%) of persons tested are part of the selected target population.
- At least 50 (1.67%), newly diagnosed HIV- positive individuals are identified;
- At least 75% of PS21-2102 HIV testing events conducted in which the client was provided screening for STDs (syphilis, gonorrhea, chlamydia), viral hepatitis, or TB in conjunction with PS21-2102 funded HIV testing)

Goal 2. Improve Health Outcomes for Persons Living with HIV

- Louisiana Objective 2A: By 2021 increase the percentage of newly diagnosed people in Louisiana who are linked to HIV medical care within one month of their HIV diagnosis to at least 85%.
- Strategy 2A-1: Establish seamless systems to link people to care immediately after diagnosis.

1-year Program Objectives: By June 30, 2022,

- At least 10 (100%) persons newly diagnosed with HIV are linked to HIV-related primary medical care within 30 days of diagnosis.
- At least 162 (27%) of persons with previously diagnosed HIV, not-in-care, are linked to HIV-related primary care within 30 days.
- At least 10 (100%) of persons with newly diagnosed HIV should be referred to Partner Services, in accordance with state and local regulations.
- At least 150 HIV+ African Americans receive LTC services with *ARTAS* support embedded into five visits.
- At least 150 HIV+ African Americans enroll into Partnerships for Health (PfH)

5-year Program Objectives: By June 30, 2026,

- At least 50 (100%) persons newly diagnosed HIV are linked to HIV-related primary care medical care within 30 days of diagnosis.
- At least 810 (27%) of persons with previously diagnosed HIV, not-in-care, are linked to HIV-related primary care within 30 days.
- At least 50 (100%) of persons with newly diagnosed HIV should be referred to Partner Services, in accordance with state and local regulations.
- At least 750 HIV+ African Americans receive LTC services with ARTAS support embedded into five visits.
- At least 750 HIV+ African Americans enroll into Partnerships for Health (PfH)

PREVENT

Goal 3: Prevent New Infections

- Louisiana Objective 3A: By 2021, Reduce disparities in the rate of new diagnoses by at least 15% among priority populations in Louisiana.
- Strategy 3A-1: Expand Prevention and Care Services to reduce HIV related disparities experienced by priority populations in Louisiana.

1-year Program Objectives: By June 30, 2022:

- 100% of HIV-negative persons referred to *PrEP*.
- At least 7,000 condoms distributed through activities for HIV-positive individuals, 2) 13,000 condoms through activities for high-risk HIV negative individuals
- At least 250 HIV+ individuals from the Target Population view the Risk Reduction Behavioral Intervention Safe in the City video intervention.
- At least 250 African Americans at High Risk for Acquiring HIV enroll in the Risk Reduction Behavioral Intervention *PROMISE*.
- At least 50 HRH African Americans who participated in PROMISE become Peer Advocate

5-year Program Objectives: By June 30, 2026:

- 100% of HIV-negative persons referred to PrEP.
- At least 35,000 condoms distributed through activities for HIV-positive individuals, 2) 65,000 condoms through activities for high-risk HIV negative individuals.
- At least 250 HIV+ individuals from the Target Population view the Risk Reduction Behavioral Intervention *Safe in the City*.
- At least 1,250 African Americans at High Risk for Acquiring HIV enroll in the Risk Reduction Behavioral Intervention PROMISE
- At least 250 HRH African Americans who participated in PROMISE become Peer Advocates
