Alaska give every citizen an annual payout. Louisiana is called LEQTF. Assets are about \$1.4 billion. . Leqtf "is the result of a 1953 federal settlement with several states over offshore drilling and development." (BESE). It is currently, dedicated to education, used for college savings plans, BESE and LEQSF.</p> <p>ii. We need to expand the sovereign wealth fund to cover all corporate profits from our resource rich state.</p> <p>iii. We need to expand the use of the sovereign wealth funds to infrastructure and climate change mitigation. Housing falls under both categories.</p> <p>iv. I also support incremental gas tax increases. As above, this tax revenue will be used to improve infrastructure, including housing and to mitigate climate change, such as installing more pumps. Currently, the cost of gas is artificially low, from subsidies and not taking into account the long term cost of fossil fuel consumption. We need to slow the use of fossil fuels in transportation. Although this may hurt low income drivers, it is a long term initiative which will help prevent additional climate change.
